- Feature a silver antimicrobial coating that protects the wristband.
- Are scannable for up to 14 days.
- Are quick and easy for staff to print and securely fasten in less than a minute using an adhesive tab or color clip.
- Are made of polypropylene and vinyl. The direct thermal imaging chemistry is composed primarily of leuco dies and developers. The inks/varnishes used are UV varnishes and water based



inks. There is no metal content in or on these particular patient identification bands. Therefore, Z-Band UltraSoft wristbands are considered to be MR-Safe.
